Discount for Timely Filing

Sales Tax Law limits discount to a maximum of \$400 per month.

No discount is allowed on Sellers or Consumers Use Tax If paid by the 20th of the month, you may take a discount of 5% of the first \$100 of TAX DUE. If you owe more than \$100 of tax, you may take an additional discount of 2% of the TAX DUE that exceeds \$100.

EXAMPLES:

\$50 Tax Due \$50 x 5%=\$2.50 discount

\$150 Tax Due- \$100 x 5%= \$5.00

\$50 x 2%= \$1.00

Avoid Expensive Penalties!

Mail your tax returns by the 15th, Delinquent after the 20th. Your monthly sales and use tax returns must be postmarked on or before the 20th of each month. Frequently, letters are not postmarked on the date they are received at the post office; therefore, a request to the Post Office for a timely postmark should be made when mailing a return on the last day for filing. There is a \$50 minimum Failure to Timely File Penalty and a 10% Failure to Timely Pay Penalty.
